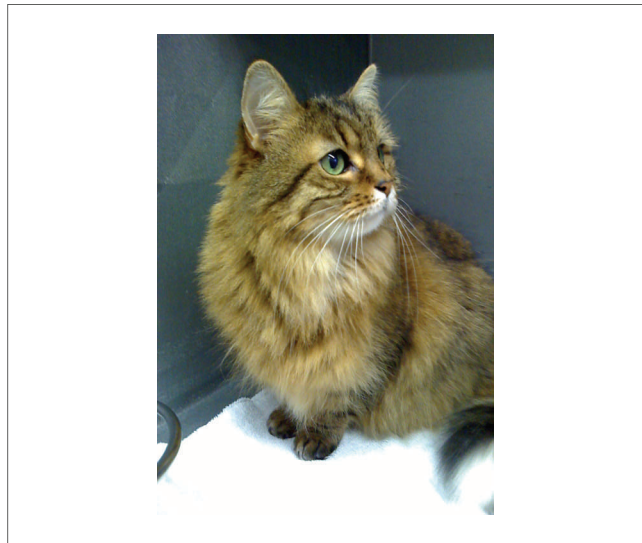

CSM STRAYS FINDS A NEW HOME FOR A SENIOR MAINE COON

Making provisions for your pets in your Will or trust is essential to their continued health and well-being if something shall happen to you. It's not something we think of. In a recent case, CSM Strays was contacted by a local veterinarian that informed us about a 12 year old Maine Coon cat whose caregiver suddenly passed away. The person left the cat to the veterinarian in her Will with no other provisions. Luckily, the veterinarian is ethical and kept the cat in the office. She was so sad and lonely and didn't understand why her mom didn't come to pick her up. CSM Stray Foundation was notified by the veterinarian. We posted the cat on Petfinder and the Senior Pet Blog. We were expecting a long wait since most people do not consider adopting a 12 year old pet. Something in our posting caught the eye of a nice lady in Brooklyn. She had a Maine Coon cat that passed away 8 months ago from old age. She called and said the line that caught her attention was "Princess deserves to have a good senior life." She filled out our application and decided to adopt the cat. Princess adjusted beautifully and is so happy to get out of a cage at the vets office. She is eating well, playing with company and sleeping with her new mom.

A Pet Trust is recommended to incorporate into your estate planning documents. It is legally enforceable while the owner is alive—even if incapacitated and after death. It's important that someone carries out your wishes and knows what your pet's needs are.

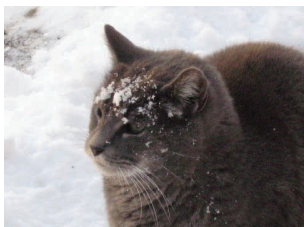

## TNR MAKES A DIFFERENCE

Trap Neuter and Return is making a difference City-wide in the control of the overpopulation of feral cats. TNR is the best humane solution to prevent more unwanted kittens from being born.

CSM Strays is most noted for reaching out to seniors of Queens that are not able to trap or reach out to the ASPCA locations. We get calls on a daily basis from seniors in Queens that claim there are kittens in their yard and the mom won't let them touch her to get to a vet. We ask the most important question, "How long have you been feeding the mom cat?" Their answers are always similar: "A little over a year." Somehow they thought that one nice cat in the yard would be the norm.

We usually have them begin a feeding pattern, once a day in the morning at exactly the same time. A veterinarian appointment is made after the mom nurses the kittens for 4 to 6 weeks. Our volunteers trap the cat the day of the appointment, have them spayed, left ear tipped and rabies shot with one of the low cost partici-



pating veterinarians they choose. We return the cat to its environment. This year we have done this for 101 cats and assisted 32 other seniors that were not able to afford the surgeries with a CSM Stray spay/neuter certificate of \$25 towards the surgery with funding from Grants from Neighborhood Cats and The PETCO Foundation. ## SENIOR SHELTER BUILDING PROGRAM

Our senior volunteers work very hard to build shelters for the feral cats of feral cat caregivers. Not only do we support the TNR projects of feral cat caregivers but offer them an opportunity to keep our seniors busy by purchasing at cost, a feral cat shelter made from Rubbermaid Roughneck containers, insulation and straw. The cost of the materials this year is \$40 and each senior that builds the shelter gets a photo of the cat(s) that use it. It keeps them motivated to do something for the cats even when they

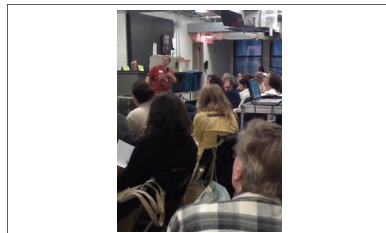
